

Privacy policy TAVOLA ROSA BASEL

1. Principle

The protection of your privacy is important to us. The following privacy policy explains which of your personal data we process and for what purpose when you visit our website or are a member of our association. This privacy policy complies with the requirements of the EU General Data Protection Regulation (GDPR) and the revised Swiss Data Protection Act (DSG). However, the applicability of these laws depends on the individual case.

3. Processing of personal data

We process the personal data that you provide to us for association purposes. In this context, we process in particular information that you voluntarily provide to us when you contact us (e.g. by post, email, social media or telephone) or when you register as an association member.

In particular, your personal data is processed for the following purposes

- Execution of the membership
- Maintenance of an address book
- Processing of invoicing and payment of membership fees
- Registration for club events
- Keeping the history of the association
- Financing of the association's activities

4. Personal data of third parties

If you transmit personal data of third parties to us, you are obliged to guarantee data protection vis-à-vis the third parties and to ensure the accuracy of the personal data.

5. Processing of personal data by third parties

We use the certified e-payment platform RaiseNow (Twint) for donations and membership fees. RaiseNow guarantees secure and simple payment and donations on the Internet. The personal data is stored in Europe, usually in Switzerland, the UK or Germany. RaiseNow collects and processes the personal data to process your payment; we do not receive any card data. RaiseNow uses the anonymised data itself for statistical purposes. More information on RaiseNow's data protection can be found here:

6. Data security

We take appropriate and suitable technical and organisational measures to ensure data protection and, in particular, data security. Once your data has been collected by TAVOLA ROSA BASEL, it will be stored for as long as is necessary for the fulfilment of the respective task, taking into account the statutory retention periods.

7. Use of the website

Cookies are files with a small amount of data that are usually used as a specific anonymous identifier. They are sent to your browser by the website you visit and stored on your computer's hard drive. TAVOLA ROSA BASEL uses these cookies to collect information and improve the website. You have the option to either accept or decline these cookies and to know when a cookie is sent to your computer. If you decide to reject our cookies, you may not be able to use some parts of the website.

8. Notifications and communications

We send notifications and communications such as newsletters by e-mail and via other communication channels such as Whatsup. Based on your consent, we will regularly send you our newsletter or similar information by e-mail to the e-mail address you have provided. When you register to receive our newsletter, the data you provide will be used exclusively for this purpose.

9. Rights of data subjects

In accordance with the EU General Data Protection Regulation (GDPR) and the revised Swiss Data Protection Act (DSG), you have the following rights:

- To obtain information as to whether and what personal data we have stored about you and to receive copies of this data
- to request the correction, supplementation or deletion of your personal data that is incorrect or is not processed in accordance with the law
- require us to restrict the processing of your personal data
- under certain circumstances, to object to the processing of your personal data or to withdraw the consent previously given for the processing
- lodge a complaint with the competent data protection supervisory authority.
